(SLVPOA), the Savannah Lakes Village Rod & Gun Club (the Rod & Gun Club), their officers, directors, members, and their agents and employees from any liability, loss, damage, costs, claims and/or causes of actions, including but not limited to all bodily and personal injuries and death and property damage arising out of my participation in any Savannah Lakes Rod and Gun Club event. I specifically understand that said activities may include the operation and use by the undersigned and/or others of firearms and ammunition or archery equipment. This Release is given on behalf of myself, my heirs, successors, executors, administrators and assigns. Furthermore, I acknowledge that:

- a) Prior to actual handling or use of any handgun, rifle, shotgun or archery equipment, I have received instruction on the use of all such firearms and equipment to be used in the activity, including but not limited to firearms to be used in any safety or training course, and fully understand their use and function. I have been provided with and have read the manufacturer's instructions included with each such item. I understand that there are inherent and other risks involved in the use of firearms, ammunition, archery equipment and related items (for example target launchers and clay targets) in shooting, and I freely and voluntarily assume and accept those risks.
- b) I hereby release the SLVPOA, the Rod & Gun Club, and their officers, directors, members, and their agents and employees from any and all liability for bodily and personal injury, death or property damage to myself or to any person or property resulting from the design, selection, installation, maintenance, adjustment, supervision or use of affiliated facilities and/or the equipment used or provided by others in such activities, including but not limited to any claim based upon negligence, breach of warranty, contract or other legal theory. I accept and assume for myself, my heirs and assigns, the full responsibility for any and all such damage, injury or death that may result.
- c) This agreement is governed by the applicable law of South Carolina. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
